Coordinating Council Recommendations for Operations (Second Reading) May 16, 2020

Having received majority approval via electronic communication to all Teaching Elders and Ruling Elder Commissioners on April 10, 2020, the Coordinating Council **recommends** the following two items:

1. On amending the Foothills Presbytery Manual of Administrative Operations:

Foothills Presbytery may meet by electronic means if all Ministers of Word and Sacrament and Ruling Elder Commissioners have reasonable notice of the electronic meeting and the ability to discuss, deliberate, discern the will of God, and vote on business items. While we shall strive for full participation, per the Book of Order (G-3.034) the Quorum for a Virtual Meeting shall be three Teaching Elders and Three Ruling Elder Commissioners from three different congregations.

2. On granting Foothills Presbytery Temporary Administrative Commission Powers:

In light of the current COVID 19 Health Crisis Foothills Presbytery authorizes the Coordinating Council to have the following additional Administrative Commission Powers:

- A. Upon recommendation of the Committee on Ministry, approve Honorable Retirements
- B. Upon the recommendation of the Examination Commission, approve the Ordination and Installation of Candidates for Ministry, and approve Ordination and/or Installation Commissions
- C. Upon the recommendation of the Committee on Preparation for Ministry, approve those under care to be approved as Candidates for the Ministry of Word and Sacrament.
- D. Upon the recommendation of the Stated Clerk, approve excused absences for the May 16, 2020 virtual Stated Meeting.
- E. That this rule be in effect until the November 2020 Stated Meeting of Presbytery.

The Report of the Presbytery Leader & Stated Clerk May 16, 2020

The Stated Clerk & Presbytery Leader **reports**:

- 1. The Committee on Shared Ministry's decision to send \$5,000 (budgeted funds) to Camp Fellowship, to be used to for the unexpected expenses. Camp Fellowship is graciously hosting the Imani Milele Children's Choir (Uganda), as they shelter in place at the camp during the COVID 19 crisis.
- 2. Endorsement from the Presbytery's Coordinating Council of the Committee on Shared Ministry's application for the Presbyterian Disaster Assistance Initial Assistance Grant of \$7,500.
- 3. In response to the COVID realities mid-March, I reached out to all our Ministers, CRE's, and Clerks, as they took steps to halt all in-person worship. Each conversation was unique. Themes included: plans for alternative ways to worship, Christian Education, pastoral care, developing alternative giving options, self-care, and interpretation of the CARES act. I will continue to keep in touch.
- 4. The COM developed a plan to reach out to all Pastoral Leaders and offer support and, if needed, connect them with presbytery resources.
- 5. I am pleased to announce the offer of free coaching sessions for Church Leaders by International Coaching Federation trained coaches, and the formation of Learning Cohorts for Pastors and Church Leaders during the climate and context of COVID 19. Writer, Speaker, and Coach MaryAnn McKibben Dana will facilitate.
- 6. Coordinating Council approved Foothills Presbytery's Application for Payroll Protection Loan.
- 7. The Covenant Connection blog focus is on God's wisdom, new learning, prayer, and the hope that arises in the amid challenge.
- 8. In partnership with the Presbyterian Foundation, we were able to offer a webinar/workshop on Stewardship in Times of Crisis. We are grateful to Olanda Carr and Paul Grier for their continued commitment to the work of Foothills Presbytery. Resources from the webinar can be found on the presbytery website.
- 9. The General Assembly of the PCUSA announced that we will not gather in Baltimore this year. We will have a condensed virtual meeting. The traditional committee process will not take place this time around, but those who were appointed as committee moderators and vice-moderators will continue to function as the Assembly Committee on Business Referral. COGA has identified a list of business to be considered in this pared-down assembly, based on items identified as "core and critical to our governance and ecclesiology." According to this plan, most business will be referred to the 225th General Assembly (2022).
- 10. The privilege of serving alongside our presbytery's ministry leaders during this unprecedented time. Your steadfast leadership and creative spirit reflect the love of God in Jesus Christ

- 5. Heard "the State of the Presbytery Update" from Debbie Foster. COM appointed a committee to work with Debbie on supporting ministers and church leaders in this time of the Covid 19 crisis.
- 6. Teaching Elder Merwyn Johnson was permitted to Labor Outside the Bounds of Foothills Presbytery in his work with "InChrist Supporting Ministries" in Charlotte Presbytery.
- 7. Heard updates from Elizabeth Little about Board of Pensions policies and programs.

The Examinations Commission met on Thursday, February 20, 2020 at the Foothills Presbytery office. Those present were Patty Felten, Bill Burns, Scott Berry, Elizabeth Clayton, Mary Morrison, Julie Schaaf, Ann Coleman, Audrey Reese, Debbie Foster, and Gordon Raynal. Elizabeth Clayton opened the meeting with prayer and a quorum was present.

The Commission met with Mary Margaret Fischer and Adam Brian Fischer by video conference to examine them for a call as co-pastors/heads of staff for St. Giles Presbyterian Church of Greenville, South Carolina. Their examination was opened with prayer by Audrey Reese. They were examined together for their calls to ministry and fit. They were examined separately in the areas of Bible, Theology, Sacraments, and Polity. Their examinations were unanimously approved. The meeting was closed with prayer by Adam Fischer.

After the congregation vote they will begin work in June and go before Presbytery at the November meeting. Their installation commission will be approved at a later date.

Their separate and identical terms of call are as follows: Cash Salary \$47,100, Housing Allowance \$18,000, SECA \$4,980.15, Pension \$7,708.82, Medical \$17,520.04, Death/disability \$700.80, FICA \$4,980.15, Reimbursable Professional expenses \$4,900, Cell phone service \$600. 4 weeks paid vacation including 4 Sundays taken concurrently with Co-Pastor, 2 weeks paid continuing education including 2 Sundays can be taken concurrently, a three month Clergy Renewal Leave in the sixth year of service with salary and benefits may be taken concurrently with Co-Pastor, pre-approved moving expenses reimbursed, and annual compensation review.

Biographical Information

I was born in Ozark, Alabama where my father served as a church musician. My parents moved our family to Bristol, TN, while my brother and I were still young. Our days were idyllic; we played in the horse pastures around our house, worked in the garden, and ate Sunday dinners with extended family. My father's professorship at a small Presbyterian college shaped our family's faith practices, education, and community. After graduating from Furman University (Greenville, SC), I went to Belfast, Northern Ireland with the Young Adult Volunteer program. Working as a peacemaker on behalf of the Presbyterian Church (U.S.A.) was extraordinarily difficult and life-changing. I returned from Belfast to serve in the Charleston-Atlantic Presbytery. Campus ministry and congregational worship reaffirmed a sense of call into ministry. Although I had not planned to attend seminary, when presented admissions forms, the essays practically wrote themselves. Thus, I followed the Spirit's energy and call to Columbia Seminary (Decatur, GA).

I served as Associate Pastor at both First Presbyterian Church (Dunedin, FL) then First Presbyterian Church (Clarksville, TN) before accepting a call to work on the *Glory to God* hymnal project (Louisville, KY). It was my privilege to serve as pastor and educator to the denomination, interpreting the committee's work to Presbyterians across the country. This unique opportunity used a number of my gifts and interests: music, teaching, writing, traveling, the larger church, and more. At its conclusion, however, I was glad to return to congregational ministry in the bounds of the Presbytery of Long Island (Melville, NY). The daily rhythm of parish life is one that I missed. From weekly prayer groups and Bible studies to monthly committee and Session meetings to local Presbytery gatherings, I truly relish my work as pastor.

While living in Louisville, KY, I met and married Rev. Adam Fischer. We have two young children, Huck (3) and Finch (infant). We enjoy adventuring outdoors and to new places, playing tabletop games, and watching binge-worthy shows. We are excited to work together as co-pastors and look forward to immersing our family in that of St. Giles!

Personal Faith Statement

I believe in the Triune God: Almighty God, Jesus Christ, and the Holy Spirit.

Rev. Adam B. Fischer Biography and Call to Ministry

I was born and raised in Coeur d' Alene, Idaho, grew up in the Pacific Northwest, the middle of three sons, romping and roaming through the wild mountains, lakes, and forests. My favorite place to be was my grandparent's lake home where they maintained a more than 100-acre wildlife sanctuary on their property. I learned to admire God's creation and live as harmoniously with it as possible.

I have attended a Presbyterian Church since I was born and have always identified as a Christian. However, it wasn't until I was on a mission trip during my junior year at Albertson College that I began to feel a call to the ministry. In the streets of Tijuana, I awakened to the reality of inequality and injustice present in the world: it was clear that God's kingdom was not fully present and that there were many people seeking to build the Kingdom of God. Returning from that trip, I sought to embody Christ's call to serve the least and I began to see the face of Christ reflected in strangers, neighbors, friends, and foes. I was well supported and nurtured by a spiritual director, campus minister, and pastoral mentor who helped me recognize and understand my call to ministry.

I went to Louisville Presbyterian Theological Seminary feeling strongly called and completely out of my league because I graduated college with honors in psychology having only taken a single religion class. I quickly discovered seminary nurtured my gifts and honed my skills. I volunteered and lived in Cape Town, South Africa for four months where I learned about forgiveness, reconciliation, and resurrection through the people's stories and the wisdom of Linda Biehl and Archbishop Desmond Tutu. I was a Theological Advisory Delegate to 217th General Assembly in Birmingham. I was a candidate under care of the Presbytery of the Inland Northwest. After graduating with an M.Div., I continued my education and earned a Master of Theology with a focus on environmental ethics and eco-theology. Throughout all of these experiences, I learned to listen and speak to people with different Biblical interpretations, theological perspectives, cultural backgrounds and practices, and life journies. I continue to grow in understanding that the Body of Christ is one body with many members.

I have worked for the church in many ways. While earning my Th.M, I worked with the Presbyterian Hunger Program. I created the "Just Living" series to help people of faith embody the scriptures through practical living. I have written for Presbyterians Today, creating the 2012 Advent Calendar devotional, "Simple Gifts." I have worked with the Montreat Youth Conference leadership teams as s small group manual writer, small group trainer, and conference leader. I have served as a pastor in ordained ministry for more than a decade.

While living in Louisville and serving at Harvey Browne Memorial Presbyterian Church, I met the Rev. Mary Margaret Flannagan. We married in 2015 and dreamed of one day working together in ministry. We moved to Long Island, New York where we have been serving two churches in transition. During this time we have grown our family and welcomed two boys, Huck and Finch who remind us to see the world with wonder. I attended interim ministry training to bolster my skills as a transitional pastor. With the help of the Presbyterian Foundation, I shepherded First Presbyterian Church of Baldwin through Project Regeneration to nurture church growth and renewal. I helped the church discover their identity by having intentional conversations and developing a mission statement to articulate God's call. I chair the Salt and Light Committee, the Presbytery of Long Island's mission committee; we strive to empower and lead the presbytery to put their faith in action.

My life has been filled with many adventures and experiences. The Spirit has led me around the world to learn about the depth and breadth of God's mercy and love. I am excited to continue to grow as a pastor and partner with the church to share the Light of Christ with the world.

Faith Statement

I believe there is a cost to proclaiming Jesus Christ as Lord and Savior; it is to live sacrificially. I believe that people are saved by God's grace, and our response to the gift of grace is to do justice, love kindness, and walk humbly with God in defiance of evil, greed, and temptations of power. I believe that sin is real and present in the world. Christ died as a sacrifice of love to free the world from the clutches of sin. In Christ's resurrection, we are all called to die to the life-draining ways of the empire and live as forgiven and forgiving disciples; we are called to share this good news with all.

I believe deeply in grace. We have all done wrong and fallen short of God's call in our lives. Christ is in the only position to condemn, yet it is Christ who sets us free. I believe that we encounter our living God in the sacraments. Ordinary elements of water, bread, and wine connect us with God as a part of a sacred ritual. We are sealed and claimed as God's own, reminded of God's grace and love poured out in living waters and overflowing cups. In the sacraments, we are woven afresh into the tapestry of the church where we are all one in Christ.

I believe in continually listening to where God is still speaking through prayer, meditation, and discernment. By studying the scriptures with others, we continue to discern God's will. The confessions enhance our understanding and guide the church further toward right action.

Christ's outreach to the poor, the downtrodden, the rejected, the oppressed, and those who do not have a voice, still serves as a prophetic witness to the entire church. I believe that the actions we take on a day-to-day basis reflect our commitment to God, testifying to our love for God and God's ability to work in and through us.

Christ has reconciled the world to God and God is working in our hearts to help us live as reconciled people, choosing love over hate, mercy over vengeance, generosity over greed, and to continually seek forgiveness. I am delighted to be a child of God and to share God's love with the world around me.

How: We will explore our mission by offering opportunities for faith formation, gatherings, fellowship, service, encouragement, resources, and support.

The Committee on Shared Ministry met on Tuesday, March 21 via Zoom. The committee reports the following:

After a prayer from Craig Foster, the CSM committee spent some time discussing the Covid-19 pandemic and checking in with those present.

- Debbie distributed a document about celebrating the Lord's Supper while worshiping online.
- One licensing is offering free licensing necessary to stream music as part of online worship
- The communications manager at Fourth Presbyterian has emailed some links for information
- Gratitude was expressed for the ability to stay connected during this time
- Debbie has been in touch with 53 of the 58 churches in the Presbytery
- Presbytery's recommendation is that congregations do not meet for in-person worship
- Presbytery has cancelled all in-person meetings

Leadership Development

The College and Vocation Discernment Team is exploring other grant options for the Intern Program for 2021. The team needs to recruit more members.

The John Roberto (Vital Faith) SC5 Leader of Leaders Event has been postponed.

The team is exploring offering workshops and training events for educators, pastors, and volunteers.

There will be an SC Minister/Educator Retreat October 26-28 in Montreat.

The 50th anniversary of APCE is in 2021. We are hoping to find creative ways to celebrate our educators in Foothills. CSM would love to see a large contingency from Foothills at the Annual Event in Chicago.

Mission Outreach

In response to a proposal from Westminster Presbyterian Church (Greenville), Greenville area congregations were contacted about partnering to build a Habitat home in the spring of 2020. At the present time, nine congregations have expressed interest in partnering to provide both finances and volunteers to enable a build. There is not enough financial backing for construction of a home. Instead, the congregations are hoping to assist with the renovations of two homes.

Rick Turner, former PDA Associate, suggested creating a PDA Program in Foothills that works with Presbyterian Women to become trainers. Recommendation made by Debbie Foster that Presbyterian Women subcommittee work with PDA on this; Natalie Schwartz will facilitate.

Hospitality, Peer Ministry, and Joys and Concerns

The Hospitality team continues to explore best practices in welcoming people into Foothills Presbytery in meaningful ways.

Communications

After a successful pilot with church websites in Foothills, Worship Times has let us know that they need 15 congregations in order to continue with \$600 per year rate. There are 21 congregations in Foothills that do not have websites. There are other churches who are in need of an update to their current website. Presbytery website in also need of a reboot.

It was mentioned that communication in this new space and time of unexpected changes in ability to worship and/or meet is an ongoing learning process. Debbie will post links for resources on our website.

Curriculum and Resources

New curriculum and resources have been ordered from Amazon and Westminster John Knox.

Outdoor Ministry

Camp Fellowship is currently housing the Imani Milele Choir. With normal operations suspended, the camp's Board of Directors met and along with staff made a commitment to shelter, feed, and nurture the group until such time as the immediate crisis ends and the choir is able to travel again. CSM sent \$5000 of the designated Outdoor Ministry budget to assist with providing shelter, food, and other needs.

Youth Ministry

The Senior High Mini Montreat was cancelled due to Covid-19. PYC is considering creative ways to celebrate the 2019-2020 year.

Applications are open for the 2020-2021 PYC.

The next meeting of the Committee on Shared Ministry will be on Tuesday, May 19 at noon. The meeting will be held via Zoom if in person meetings are still restricted at that time.

Foothills Presbytery Coordinating Council Report May 16, 2020

- I. The Coordinating Council **reports** the following actions since the February 18, 2020 Stated Meeting of Presbytery:
 - A. Approved the request of First Simpsonville to rent their facilities to the Deeper Life Bible Fellowship and for them to use the sanctuary.
 - B. Approved the request of First Simpsonville to allow the Lamb of God Lutheran Fellowship to use the sanctuary.
 - C. Approved the listing of the property of the former Pelzer Presbyterian Church with Berkeshire Hathaway Realtors.
 - D. At its April 7 Stated Meeting approved a three-part proposal to recommend to the Sessions of the 58 Congregations of Foothills Presbytery, and in this time of the COVID 19 crisis for these proposals to represent a first reading regarding changing the Foothills Presbytery Manual of Administrative Operations:
 - 1. Foothills Presbytery may meet by electronic means if all Ministers of Word and Sacrament and Ruling Elder Commissioners have reasonable notice of the electronic meeting and the ability to discuss, deliberate, discern the will of God, and vote on business items. While we shall strive for full participation, per the Book of Order (G-3.034) the Quorum for a Virtual Meeting shall be three Teaching Elders and Three Ruling Elder Commissioners from three different congregations.
 - 2. Pending the approval of the above to hold the May 16, 2020 Stated Meeting of Presbytery via electronic means.
 - 3. In light of the current COVID 19 Health Crisis Foothills Presbytery authorizes the Coordinating Council to have the following additional Administrative Commission Powers:

Upon recommendation of the Committee on Ministry, approve Honorable Retirements

Upon the recommendation of the Examination Commission, approve the Ordination and Installation of Candidates for Ministry, and approve Ordination and/or Installation Commissions

Upon the recommendation of the Committee on Preparation for Ministry, approve those under care to be approved as Candidates for the Ministry of Word and Sacrament.

Upon the recommendation of the Stated Clerk, approve excused absences for the May 16, 2020 virtual Stated Meeting.

That this rule be in effect until the November 2020 Stated Meeting of Presbytery.

(See Docket items IV and V for the recommendations for a Second Reading and Approval of the above.)

- E. Heard the reports and communications from the Committees and Commissions of Presbytery and from Presbytery staff, and reviewed and approved the Proposed Docket for the May 16, 2020 Stated Meeting of Foothills Presbytery (#113). The Report of the Stated Clerk and all committee reports were placed on the *Consent* Agenda. The only action items will be the consideration of the above-mentioned proposals for change and temporary modification of the Foothills Presbytery Manual of Administrative Operations. Also, the Coordinating Council thanks Ruling Elder Sidney Mize (Central Church) for her faithful service as Moderator for the last year. Sidney will pass the gavel to the Moderator-Elect, Teaching Elder Tom Evans (First Spartanburg) as he begins his term of service. In addition, the April 7, 2020 Stated Meeting of the Council was the last for Gordon Raynal who served Foothills for 6 ½ years as Stated Clerk, and now as Associate Stated Clerk. He is scheduled to retire on July 31^s, but may stay on additional time until the new Associate Stated Clerk is employed and trained. The Coordinating Council recommends adoption of the Docket. The Stated Clerk will present this recommendation as the usual time.
- II. The Coordinating Council **reports** the following information:
 - A. The Council received a report from the Stated Clerk and an update on the ongoing work of the Transition Think Tank:

Debbie began the report by talking about her and the staff's work during this COVID 19 crisis. At the outset she was in touch with all the pastors. All congregations have closed down in-person worship. She expressed thanks to all the leaders for their faithful work amidst the crisis. On the Presbytery level we have canceled all in-person meetings and have shifted to Zoom meetings. The Presbytery Office is open in shifts for Presbytery Staff alone. Leanne is there on Monday and Wednesdays. Debbie is there on Tuesday and Thursdays. Warren works 2nd shift Monday, Wednesday and when needed, on Fridays. Gordon works from home.

Future Church Update:

Debbie continues her conversations with Olanda Carr (Presbyterian Foundation) regarding the Legacy Project. Focus has shifted to the immediate circumstances. Olanda and Paul Grier are scheduled to do a Zoom Webinar on stewardship on

April 16th. Work in terms of Faithful Innovation has shifted to work on learning cohorts focused around adapting to the circumstances of the crisis.

Various Council members described their adaptive work in terms of worship and congregational life during this crisis. Tom Evans noted an increase in worship attendance. Others concurred with this observation. Other conversation centered around youth work and focus on worship at home for those who don't utilize the internet.

- B. Council received the following Communications from the Stated Clerk, the Associate Stated Clerk and the Treasurer:
- 1. Gordon reported about the ongoing work on the other parts of the Manual of Administrative Operations: Sexual Misconduct policy draft being worked on; Personnel Manual at the attorney for review; Finance & Stewardship: the Investment Committee part is complete and approved by Presbytery at the February 2020 Stated Meeting; the pieces on usual office practices and best practices for our congregations is in development.
- 2. Debbie reported that some of the members of the Scholarship Working Group met via Zoom to review the work completed by the previous group appointed by Discernment Task Force, and reviewed the areas for the work ahead. Another meeting has been scheduled to begin to work on the policies, procedures and forms necessary to put the new program for scholarships for Candidates, and those seeking to become CRE's and CCE's in place.
- 3. Debbie and Gordon reported that the Search Committees for the Associate Stated Clerk and the Associate for Mission and Ministry were continuing to meet by Zoom and that both were interviewing or preparing to interview candidates for the positions.
- 4. Gordon reported that the 2020 SC5 Convocation had been canceled due to the COVID 19 crisis. The hope is that it will be rescheduled for next year.
- 5. Gordon shared the thank you letter from the pastor and Session of Tyger River.
- 6. There was no "Circle Up" update at this time.
- 7. There was no report regarding GA Connections at this time.
- 8. Debbie reported about the great support and work of our Synod Stated Clerk and Executive, Joyce Lieberman.
- 9. There was no report regarding Regional Connections at this time.
- 10. Stan reported on the good work of the Investment Committee. Like all we have lost money in the falling Stock Market (down approximately \$159,000), but that

- over the last year we have earned approximately \$66,000. Presbytery continues to have a strong "cash on hand" position.
- 11. Gordon reported regarding the West Georgia Road and Pelzer properties. The house at West Georgia Road was vandalized. The police were notified and are investigating. The house mover still wants the house and will hopefully move it in the months to come. After that, we will get the property cleaned up. Gordon reported that the attorney and small group of citizens in Pelzer continue to complain about the closure of the church. They offered \$35,000 for the property, which we ignored. Debbie emphasized the need to care for the community as the current pastor, Aaron Ochart is taking a new call this summer. The Pelzer property is listed.
- 12. CARES Act: Debbie, Dennis Latham and Stan presented information on the CARES Act passed by the U.S. government. The F&S Committee will seek to be a resource to our congregations seeks these government loans. Council approved Presbytery seeking one of these loans. Debbie and Warren are working on the paperwork.
