Report of the Presbytery Leader and Stated Clerk October 6, 2020

The Stated Clerk reports:

- 1. Foothills Presbytery received a robust "thank you" from LaShauna Harrison, the CEO of the United Way of Oconee County, for the \$8,300 sent for clean-up efforts after the Easter Tornado came through the greater Seneca area.
- 2. The final Presbyterian Disaster Assistance Grant Distribution of \$2,640 was sent to Habitat for Humanity. John Goyert, of Habitat for Humanity, is at the center of Habitat's tornado recovery repair and rebuilding. He is a member of the Oconee County Long Term Recovery Group (OCLTRG) and heading up the rebuilding/repair work.
- 3. Council approved an offer from Anderson Ridge Development LLC for \$1,050,000.00 (\$50,000 in earnest money) on the West Georgia Rd property.
- 4. Support for pastors and church leaders during the COVID-19 pandemic continues to be a priority of all the presbytery staff and the core missional committees of Presbytery. As spikes of COVID-19 cases rise, we need to remember to proceed with an abundance of caution.
 - a. As of Labor Day, 17 of the 58 churches in the presbytery hosted in-person/indoor worship. Over the last few weeks, six more have opened for in-person/indoor worship, and more are scheduled to start in November.
 - b. I was honored to work with the CSM, Worship Committee, and Music Director Peer Ministry to create a virtual worship service, hoping that it would provide a sabbath for pastors and church leaders.
 - c. Zoom check-in gatherings are taking place with pastors, educators, youth directors, and music leaders.

The Presbytery office continues to host virtual meetings (via Zoom) and has opened the large conference room for (up to nine) to meet w/masks and social distancing.

- 5. The PCUSA Board of Pensions invited a group of Synod and Presbytery Executives to participate (virtually) in CREDO. Created initially for pastors to cultivate wholeness (spiritual, vocational, health, and financial well-being), this year was the first cohort of Presbytery and Synod Leaders. I am thankful that I was invited to participate September 21- 24.
- 6. September 16th, the five Presbytery leaders in SC, invited Elliot Smith, Executive Director of Thornwell, to join us (via Zoom) Elliot provided an update on Thornwell's response to recent press coverage about its founder, the Rev. Dr. William P. Jacobs, and its namesake, the Rev. James H. Thornwell. Thornwell preached a doctrine that claimed slavery to be morally right and justified by the tenets of Christianity. The Board of Trustees of Thornwell has formed a committee to determine how the board could be more diverse and how it could speak to the issues of structural and systemic racism in Thornwell's history and consider how it informs their future. Elliot expressed appreciation for the conversation. The SC5 Executives are the first outside group that they have been in conversation with regarding Thornwell's past.
- 7. Our new Associate Stated Clerk, Robin Morris, and I were invited to join other Presbytery Leaders in the Synod of the South Atlantic in a book study of the Robert Jones' book, *White Too Long*. Jones

delivers a provocative examination of the relationship between American Christianity and white supremacy and issues an urgent call for white Christians to reckon with this legacy for the sake of themselves and the nation. It is recommended reading for all church leaders.

- 8. We have received and declined an offer on the Pelzer Church Property. We continue to support the Faith Church as they work through a punch list to close out the final details with the SC Secretary of State to close the Pelzer church (old) as a corporation.
- 9. The Richland Church (Art Williams, Moderator) continues to be in negotiations over a lawsuit demanding the church honor a right-away agreement.
- 10. Foothills Presbytery was contacted by the board of the Old Stone Church as they were in negotiations to sell a small portion of their cemetery/property. No action was needed by presbytery.
- 11. The Transition Think Tank continues its work focusing on Presbytery's new model, the issues of our current culture and context.
 - a. In September, we welcomed Tim Cargal, from the Office of General Assembly, who gave an in-depth presentation entitled the <u>Future Shape of Ministry</u>. The information included leadership development, demographic changes, ministry context, and PC(USA) membership information.
 - b. The data from Tim will inform the Legacy Partnership Project's continued work. This project is designed for churches who would like to spend in-depth time considering their future. There will be study materials and 4-5 meetings during this time as the congregations consider their assets/liabilities and discern their future. Foothills Presbytery is a pilot presbytery and will be working closely with Olanda Carr, Senior Ministry Relations Officer (Presbyterian Foundation).
- 12. On behalf of Council, I offer a warm welcome to our new Associate for Shared Mission and Ministry, the Reverend Pressley Cox. Pressley started in her new role on October 1.
- 13. In her first ninety days, our new Associate Stated Clerk, Robin Morris, has been training and completing continuing education to ensure a solid foundation. Her onboarding began with Gordon Raynal and me with orientation around all things Foothills Presbytery. Robin also took a virtual *Polity Class* sponsored by OGA and taught by Joyce Lieberman (Exec/Stated Clerk of the Synod of South Atlantic), and the Board of Pensions webinar, *Just Compensation: Closing the Gender Gap*, taught by the Rev. Lori Neff LaRue. Since July, Robin's primary focus has been reviewing and updating all of our policy manuals, procedures, and tools. She continues to meet our presbytery leaders (virtually) and has already demonstrated why she is an asset to the mission and ministry of Foothills Presbytery.
- 14. We continue to work on updating the Manual of Operations. Two upcoming additions:
 - a. The Personnel Committee has completed its policy manual and has sent it to for a legal review.
 - b. The Coordinating Councils' decision to create a new Antiracism Ministry Team will need to be added to the Manual.

The Stated Clerk recommends:

1. Having received requests for an excuse for the November 10, 2020 Stated Meeting of Foothills Presbytery, and having found them in order, moves their approval.

224th, General Assembly Report Rev Mel Davis Foothills Presbytery

I was so excited about going to Baltimore. It is my Mom's hometown. I have relatives that I had planned to visit and to re-connect memories. I was extremely excited about representing Foothills as a commissioner. I have served as a commissioner once before and it was such a wonderful experience, serving on a committee and seeing friends from over the years. It was truly a thrilling experience when we met in Cincinnati. But that was then, and this is now. What a drastic change has shaken us.

This assembly got what work it could do accomplished. It took patience and concentration. I sat at my computer and sat at my computer and sat some more. I am sure that I have never sat as long in one place for so long in my entire life. But you know what? We got it done, we hung in there, we listened, we reconsidered, we substituted motions, the parliamentarian was consulted often, and, in the end, we completed the tasks set before us. We stayed the course and we all survived.

Through the course of the meeting we realized in a new way how important it is for us as a national church to address our nation's social issues. We have work to do! Covid-19 did not stop us! We are called to be voices of hope in our sometimes-chaotic world. We are still the Church and the light of the world!

I would like to commend our other commissioners for their detailed reports from their experiences. I will not attempt to re do what they have done so well. I would like for all to know how much it meant to have the support of our presbytery staff. They went beyond the call of duty to make sure we had what we needed to do our work. I am sure the host presbytery, Baltimore was extremely disappointed and I am grateful for their work. Much planning and effort went into the pre-planning. And last our GA staff and co-moderators were exceptional in making this as painless as possible.

224th GENERAL ASSEMBLY REPORT (Week of June 19-27th, 2020) Rev. Leslie Lang, Teaching Elder Commissioner Foothills Presbytery

This General Assembly was one like no other before it, and I am praying to God that there will be no more like it in the future (10 hours on Zoom is exhausting!) Due to Covid-19, the Office of the General Assembly decided that the in-person gathering in Baltimore, MD, would be moved to a virtual format.

I was so excited and honored to be asked to serve as a commissioner, especially when I learned that roughly only 6.5% of the commissioners were under 35 years old (so a shout-out to Foothills Presbytery for sending one!). I was disappointed when the decision was made to hold the assembly online. I was sad to miss out on the in-person fellowship, worship, and overall experience of being physically together with hundreds of Presbyterians in one room for a week. After a stressful day with some technology and communication mishaps, I signed into the opening plenary on Friday, June 19th, stressed and weary before the meeting had even begun.

The June 19th meeting commenced with worship, where J. Herbert Nelson, stated clerk, spoke about the importance of gathering in this critical time in history, especially as a predominately white denomination. His wise words, even in the midst of everything going on in our world, was "Do not be sorrowful; we come with joy because God is with us and God has chosen us, by grace, to be the ones to lead the way." I felt the power of being commissioned, even through a computer screen. It was the reminder I needed that God's grace is enough, and that God had called each of us to this place and had equipped us to serve in this way and in this particular time.

After worship and the commissioning, outgoing co-moderators Vilmarie Cintrón-Olivieri and Cindy Kohlmann welcomed, gave their report, and led us through a voting orientation. All voting was done electronically through PC-Biz, while the assembly itself simultaneously convened over Zoom. Because of meeting electronically, the Assembly voted on special rules to conduct business. The evening also included voting on the agenda, which was split into three separate parts: Information to Receive that does not Require Action, Items to be Discussed and Voted on during this Assembly, and Items to Refer to the 225th General Assembly in 2022. After much discussion and debate, several changes were made to the agenda:

- An item to address systemic racism and racial injustice (00-29)
- o An item to address Covid-19 (00-30)
- Two items removed from consent agenda to discuss during this assembly: Native American Coordinating Council report and the Native American Church property report

This meeting was running much later than anticipated, so there was a vote to move the Voting and Installation of the new Co-moderators to Saturday, June 20th at 7pm. That evening, Rev. Gregory Bentley from Huntsville, AL, and Elona Street-Steward from the Twin Cities were elected as the new co-moderators by an overwhelming majority. Both co-moderators are people of color, and Elona is the first ever Native American moderator of the General Assembly.

The next plenary sessions took place on Friday, June 26th and Saturday, June 27th. Friday morning opened with worship, with the theme, "From Lamentation, to Repentance, to Hope, to Action." Outgoing co-moderators Cintrón-Olivieri and Kohlmann co-preached on the text Ephesians 3:14-21. There was pause to lament the violence of the Coronavirus, the violence of racist structures and white supremacy, and the poverty of our world. We must lament and acknowledge the ways we have contributed to these injustices. But lament is

accompanied by hope as we long for new beginnings. They reminded us of our vow "to pray for and serve the people with energy, intelligence, imagination, and love." This vow has always been important, but it is especially so now. We celebrated communion virtually.

We began the business portion of the meeting. Several motions were approved to approve nominations for leadership positions, including electing Jihyun Oh as Associate Stated Clerk.

There was a lot of debate and revisions on motion 00-29, "On the Church in This Moment in History." Many believed that the original motion put forth by the Committee on the Office of General Assembly did not go far enough in addressing the current issues at hand; a substitute motion was presented and approved by the GA which went into more explicit detail about how we plan to address the issues of racism in our current time.

Motion 00-30 was also slightly amended and passed entitled, "Responding to the Covid-19 Pandemic." We also voted to approve the Native American Coordinator Council Report and the Native American Property Report (00-95 and 00-96). These reports call for funding for the buildings of Native Presbyterian churches, for the Church at all levels to develop partnerships with indigenous-led communities and groups, and for the sales of church properties to return land to indigenous people, among other things.

The Saturday Session opened with the Re-Election of J. Herbert Nelson as Stated Clerk for a second 4-year term. He was re-elected with 94% of the vote. J. Herbert Nelson reminded us that that church is not dying; it is reforming. He called for the church not to be an esoteric institution, but a movement, one that follows Jesus in answering the call of social justice. He also reminded us during this pandemic, "We have learned that the building is not essential to the work that we have to do to the church; it is not essential for sharing the love of Jesus Christ in the world. In fact, I don't ever remember Jesus having a church house." I was encouraged, inspired, and hopeful for the next 4 years under his continued leadership.

The Assembly voted and approved amendments to PCUSA Child/Youth/Vulnerable Adult Protection Policy (00-05), as well as many other minor motions. There was much discussion over the budget for 2021-2022, but ultimately it was approved. The 2021 Budget is a 25% decrease from 2020 to account for anticipated effects of Coronavirus and expected drop in per capita giving.

In order to receive new business, there had to be a 2/3 vote approving to suspend the rules to discuss new motions. There were two attempts to do so: a motion to adopt a statement about black women and girls, and a motion to develop a taskforce to address issues of the pre-born. Both times, the motion to suspend the rules failed, so these items were not discussed. J. Herbert Nelson led us in prayer lamenting the mistreatment and the injustices of black women and girls at the end of the meeting.

We observed 8 minutes and 46 seconds of silence before closing, in accordance with the mended 00-29 motion, which stated, "Direct the Co-Moderators of the 224th General Assembly to facilitate a time of silent vigil of 8 minutes and 46 seconds as a symbolic representation in solidarity with our BIPOC siblings, and of corporate lament and personal introspection of our complicity in perpetuating systemic racism and racial injustice before adjourning the 224th General Assembly." The Assembly closed with worship on Saturday evening.

Report to Foothills Presbytery of the 224th General Assembly

"Why have you forgotten us completely? Why have you forsaken us these many days? Restore us to yourself, O Lord, that we may be restored; renew our days as of old." Lamentations 5:20-21. "From Lamentation to Hope" was the theme of the 224th General Assembly. Certainly, lamentation is something we are all experiencing during this time of global pandemic and renewed calls for an end to racial injustice and inequity. I was thrilled and honored to be asked to serve as a commissioner to the General Assembly! I am a life long Presbyterian and serving as a commissioner has long been on my bucket list. I was still excited to serve even when it became clear that this General Assembly would not be held in Baltimore, but via Zoom in my bedroom in Greenville. Please allow me a moment of whining-4 days of Zoom meetings lasting from 2 1/2-10 hours was exhausting. And I certainly missed the opportunity to meet and worship with fellow Presbyterians in person. To participate in the meetings and to vote required 2 devices (for me, 2 computers): 1 for the actual Zoom meeting with all the commissioners and attendees and 1 for PC-Biz. PC-Biz was the website where all of the business of the GA was done and which required a scheduled tutorial a couple of weeks before the GA.

The opening plenary began at 7:00 pm on Friday June 19th. I was ready with my 2 computers up and running and, gratefully, had no problems accessing the Zoom meeting and PC-Biz. The session began with a worship service. Although I was disappointed in not attending in person, I was surprised that the act of worship and the commissioning made me feel much more a part of this General Assembly than I had at the beginning of the evening. Next, Cindy Kohlmann and Vilmarie Cintron-Olivieri, outgoing comoderators, began the business part of the meeting. We voted on the agenda and on special rules to conduct business electronically. The final item of business for the evening was to vote for new comoderators. However, by the time we were ready to do that, it was 11:15 pm. Since this process usually takes a couple of hours (my usual bedtime is 9:00!) there was a vote to reconvene at 7:00 pm on Saturday evening. I thoroughly enjoyed this process! There were 3 pairs of potential co-moderators. Each spoke briefly about their goals and vision for the PCUSA, then there was time for questions. Elona Street-Steward, the first Native American moderator, and Rev. Gregory Bentley were elected as co-moderators.

Saturday June 20th was the Poor People's Assembly and Moral March on Washington. This was a virtual event, not a physical march, and was supported by the PCUSA. The Poor People's Campaign is addressing multiple issues affecting the poor: housing, health care, police brutality, hunger, racism. In this virtual march, individuals living in poverty told their own stories. It was a powerful reminder that we, as a rich nation, have millions of our citizens unable to access health care, healthy food or affordable housing. This "March" was a call to action for all who want to see equity and justice for all people.

The plenary session on Friday June 26th opened with worship at 11:00 am. We then proceeded to business. The most debate was on agenda item 00-29—On the Church in this Moment in History—which was a call to action to address racial injustice. Several amendments were added to affirm that Black lives matter and for action to remove systemic racism. Agenda item 00-30—On Responding to the Covid-19 Pandemic—was amended to include care and advocacy for marginalized persons most afflicted by coronavirus: LGBTQ persons and Black, Indigenous and People of Color. Agenda items 00-95 and 00-96 addressed issues of Native American churches, particularly funding for repairs to church property.

On Saturday June 27th, the plenary session began with the election of J. Herbert Nelson as Stated Clerk for a second term. In his beautiful address, he reminded us that the roadmap is not clear and we walk by faith. He challenged us that the church building should not be where the work of the church happens. We are called to be the church Jesus Christ wants us to be.

I will admit that my eyes tend to glaze over during budgetary discussions and this was true on Saturday afternoon. The Office of the General Assembly received a Payroll Protection Program Loan of 8.8 million dollars to continue to pay staff during the pandemic. It was announced that there will likely be around \$14,000,000 in budgetary shortfalls over the next 2 years due to the pandemic. The budget for 2021 was approved but is decreased by 25% from 2020 due to the projected loss of income from the pandemic.

There were 2 attempts to suspend the rules to discuss new business. These motions dealt with concerns for black women and girls; particularly dealing with enslaved women being forced to bear children. The Young Adult Advisory Delegates were particularly frustrated that these attempts to suspend the rules were rejected. At the end of the business portion of the day, J. Herbert Nelson led a prayer in support of black women and girls and to challenge the church to work toward eliminating the injustices done to women of color. We then had 8 minutes 46 seconds of silent meditation and prayer to reflect on "our complicity in perpetuating systemic racism" and in "solidarity with our BIPOC siblings".

General Assembly notes and reflections From Jimmy Cheeks

The most important message is to love the poor. Jesus said: "Blessed are the poor, for theirs is the Kingdom of God!" (Lk 6:20)

Most Commissioners believe that the Church should focus on the poor and sick especially during this pandemic. Many cannot wait for the next Assembly to begin to address the poverty in our communities of many colors. Amendments that will prolong the Assembly were discussed, voted, and approved to address poor conditions of our Native American churches and poverty.

There was much dialogue on changing our white churches to reflect the world we live in. We must acknowledge the past, teach all history, and remove idols that teach bigotry and fear.

Some Commissioners stated that we should confess our past racism and admit to the pain and symbolism from slavery that continues to plague African Americans today.

And some said that we should acknowledge the displacement of Native Americans in order to SEE who is who, and who was here first.

The white race is a conundrum of many European countries who fled Europe to escape poverty and persecution only to inflict the same pain on persons of different colors or cultures. Many don't even know who they are? However, they managed to unite as one WHITE race.

I believe that we better understand each other by our associations with folks from all skin colors.

When we segregate our churches and our communities, we only see ourselves.

Appreciating different people's cultures is the vaccine to inoculate us from racism.

The Tower of Babel became our great distraction. We tried to build an edifice that distracted us; from 'God's gift of life'.

Now we need to appreciate our differences in order to see ourselves and love one another.

I was surprised at how candid some of the discussions were. This is my story.

- Of course I agree, but it is all happening so fast. I am 71 years old and I've lived in two worlds and not accepted in either, because I'm gay.
- I am so proud of PCUSA. Their focus is on the poor and the oppressed.
- I've been Roman Catholic, Baptist, Methodist; I have been negro, nigger, colored, black;
- I've been spit on by white supremacists because of my skin color; jim crow determined where I could live or work; school segregation was my reality; and being bullied for being different was administered by anyone who needed to feel better. (by any race.)

SYNOD OF SOUTH ATLANTIC 34th ZOOM STATED MEETING THURSDAY, AUGUST 6, 2020

HIGHLIGHTS

- The Rev. Kathi Parchem, Synod Moderator, welcomed first-time and returning Commissioners, Presbytery Leaders, Stated Clerks, Racial Ethnic Leaders, the Synod Presbyterian Women Leader, and guests gathered to conduct the business of the Synod. Due to the pandemic the May Stated Meeting was cancelled so the Synod held its first electronic meeting using ZOOM video conferencing.
- The Rev. Rick Douylliez of the St. Marys Presbyterian Church, Savannah Presbytery, led the Synod in worship using Matthew 14:22-33 as the scripture.
- During worship, the Synod Moderator, the Rev. Kathi Parchem, Savannah Presbytery, and the Synod Moderator-Elect, the Rev. Dr. David Shelor, Tampa Bay Presbytery, were installed with former moderator, Gloria Graham Boyd, asking the installation questions of the Moderator, Moderator-Elect, and the Synod.
- Joyce Lieberman, Synod Executive and Stated Clerk, reported on the status of the Synod, including the
 membership, the Presbytery and Synod minutes approvals, and Permanent Judicial Commission
 decisions. She welcomed the new Presbytery leaders and Clerks to the Synod. She reflected upon the
 "new normal" of what it means to be the church in this time and place, with widespread COVID and
 widespread racism.
- The Executive Administrative Commission (EAC) presented a number of proposed Synod Manual of Operations changes and updates as a first reading.
- The Synod voted in favor of the 2021 Stated Meeting dates of April 22-23, 2021 at Epworth-By-The-Sea, St. Simons Island, Georgia, as well as an electronic meeting on November 5, 2021.
- Jodi Dodge, Synod Treasurer, was elected to serve another four-year term. Her gifts, expertise and innovations have supported the Synod's staff and the Budget and Finance Committee.
- William "Bill" Byars, Cherokee Presbytery, was elected as the Chair of the Administration and Relationships Committee (ARC). Ken Whitehurst, Greater Atlanta Presbytery was elected as the Chair of the Ministry Support Committee (MSC).
- The Synod audit for 2019 was completed and in order. The 2021 proposed budget was approved with per capita remaining at \$1.50 and suggested mission giving remaining at \$1.00.
- The Rev. Dr. Alan Baroody read the Ahmaud Arbery Statement from Savannah and Greater Atlanta Presbyteries, which was responded to by the other Georgia Presbyteries.

Bio & Call Statement

I was welcomed into the community of faith at my baptism on May 14, 1989 at Easley Presbyterian Church. It has been more than 4 years since my seminary journey began. In that time, God has given April and me two beautiful children and has given me new opportunities for work outside GE. Since beginning my studies, I have learned the importance of setting realistic expectations for myself and have found the limits of my time management abilities. God continues to teach me what this calling will look like. April and I look forward to growing into the life toward which God calls us.

Statement of Faith

I believe that God exists in completeness as a perfect unity of three in one: Father, Son, Holy Spirit. In an outpouring of the perfect self-giving love of the trinity, God is continually creating, sustaining, and redeeming all things according to God's sovereign will. The humble power of God, exercised in love, is sovereign over all of creation, and only God can prevail over the evil that exists in the world.

Jesus Christ, the second person of the trinity, is God in human flesh; fully human and fully divine. Jesus Christ lived, taught, suffered, died, and was raised according to the will of God. In Christ, God emptied Godself and died a humiliating death upon a cross; taking upon himself our sin and brokenness. In his resurrection, God in Christ was victorious over sin and death. In him, God elected all of humanity for redemption. Christ is our life's example and our salvation. He came to preach good news to the poor and he calls us to lives of loving service in gratitude for his grace. We look to his second coming as a time when God's love will triumph over every evil. The work of the Kingdom that God inaugurated in Christ will come to completion, and God "will wipe away every tear from their eyes."

I believe that the Holy Spirit is the power of God at work in all times and places. The kingdom which Christ inaugurated is made present by the Holy Spirit. The Spirit lives, moves, and loves; gathering us to one another and to God. The Spirit opens the possibility for sinful humanity to be reconciled to one another and to God. In our baptism, the Spirit of God greets us. The Spirit walks with us in our lives, transforming us to become who we are called to be.

I believe that God revealed Godself most fully in the witness of Scripture. It is through Scripture, by the power of the Holy Spirit, that we come to know God in Christ. The Scriptures record the experience of God's covenant people and their encounters with the God who loves them. These accounts, written by human beings, illuminated by the Holy Spirit, bear the marks of the cultural understandings of the times in which they were written. They should, therefore, always be interpreted in light of the witness of the love and grace of God in Christ.

I believe that Christ instituted two sacraments: Baptism and the Eucharist. John Calvin referred to sacraments as visible words. Making what is intangible tangible. Allowing us to experience with our bodies the reality of what we know in our hearts: the overwhelming grace of God. Sacraments give us a sense of the fact that God works and loves the physical world. God created, and it was good. The sacraments celebrate that goodness. They are our way of responding to God's grace in gratitude and in community.

I believe that Church, as Calvin said, is where the word is read and heard and the sacraments are administered according to Jesus Christ. This body, called to be Christ's hands and feet, have been tasked with proclaiming the Gospel of Jesus Christ in word and deed. The church, continually reforming through the power of the Holy Spirit, strives to participate in God's mission of love and service to all creation.

Mission: To equip, connect, and nurture the churches of Foothills Presbytery.

Core Values: We will celebrate an adaptive environment where grace abounds while striving to strengthen our connectional church and share mission in a spirit of experimentation.

How: We will explore our mission by offering opportunities for faith formation, gatherings, fellowship, service, encouragement, resources, and support.

Since the August Presbytery meeting, the Committee on Shared Ministry met via Zoom on Tuesday, September 15. The committee reports the following:

Leadership Development

The College and Vocation Discernment Team used funds from the 2020 budget to support Camp Fellowship's summer staff leadership program. The team continues to explore grant options for the Intern Program for 2021.

The SC5 Leader of Leaders Event with John Roberto (Vital Faith) was postponed to the spring of 2021.

There will be a virtual SC Minister/Educator Retreat October 26-28 with Dr. Sam Adams (Union Presbyterian Seminary), Old Testament Wisdom, The Bible and Politics. This event is usually held at Montreat, but has shifted to a shorter, two-day virtual event. https://foothillspresbytery.org/events/virtual-retreat-october-27-28/

The APCE annual event has shifted to a virtual retreat to be held in early February 2021. The event will cost around \$100 per person. Given the lower participant fee, Foothills hopes to support more participants for this Annual Event. The scholarship request form will be made available in early November. The 50th anniversary celebration will now happen at the 2022 Annual Event (Feb 9-12).

CSM approved an opportunity for some of our Presbytery pastors to work with Ministry Architects in a cohort setting. The cohort of 8-10 pastors will meet for a 5-week period creating tangible plans for the season of Advent. Each pastor will come away with an individualized plan for Advent based on their ministry setting. The plans may include virtual, in-person, or hybrid worship as well as educational components.

The total cost of the proposal is \$3,410. As there are varying size and financial abilities of congregations, the pricing would be a tiered approach.

The total cost of this Continuing Education Cohort is \$430 per person if there are 8 participants. Recognizing the financial burdens that some churches are feeling at this time, Foothills Presbytery is pleased to offer Investment Option pricing for pastors.

Green Option- Name your price! Does your church have extra money for continuing education? Any amount above \$430 will help support someone else.

Blue Option-\$430 This option covers the full price of the program.

Red Option- \$250 This option provides a discount for those who may not have as much in their 2020 continuing education budget.

Purple Option- \$50 This option provides a deep discount for churches that are facing significant financial burdens.

The venture will be subsidized by both CSM funds, as well as Presbytery funds designated for ministries of CSM.

Mission Outreach

<u>Cents-Ability</u>: Congregations participating in this ministry are encouraged to continue this offering given to help alleviate hunger. Ideas for promoting this ministry were shared.

<u>Foothills Collaborative Habitat Build:</u> Building is on hold until COVID-19 numbers are at levels mandated by Habitat for Humanity.

<u>Foothills PDA</u> A draft Disaster Preparedness and Response plan was presented to the committee to review. After CSM reviews the plan at a future meeting, it will be sent to Presbytery Council for review and approval before being shared with congregations.

<u>South Carolina Presbyterian Disaster Assistance Team (SC-PDAT)</u> Rick Turner reported representatives from the five SC presbyteries have been meeting. Pressley Cox is representing Foothills Presbytery. Working with Presbyterian Women, PDA held virtual training sessions and eleven Disaster Preparedness Trainers were commissioned.

Hospitality, Peer Ministry, and Joys and Concerns

The Hospitality team continues to explore best practices in welcoming people into Foothills Presbytery in meaningful ways.

The following peer groups are currently meeting via Zoom and supported by the CSM:

- Large Church Children's Educators
- Youth Leader Roundtable
- Church Music Directors/Leaders

The Committee is exploring ways to connect ministers, educators, and leaders through other peer groups and cohorts during this time when so many are not gathering in person.

Joys and concerns are still being shared with the presbytery.

Communications

If needed, help is available to assist with streaming and technology issues. A technology grant will be available from the Future Church Fund. Information about best practices is also being developed.

Curriculum and Resources

Pat Shufeldt is in the process of adding HOOPLA (public library program) to the Westminster Presbyterian library data base and will import to the Presbytery resource website.

Outdoor Ministry

The choir from Uganda at Camp Fellowship will be there through the end of November and questions were raised about what help may be needed. Report was given about the Fall Adult Retreat (virtual).

Youth Ministry

PYC Coordinator Joan Jones shared the following:

PYC met on Saturday, August 22 from 9-4 for our planning retreat. This was our first in person gathering since March. We welcomed our new members and spent time getting to know one another all while socially distancing outside at Eastminster Presbyterian.

Some of our Seniors led us in "get to know you" games and allowed us to learn some new games that we can use when we are able to gather with other youth groups.

We spent a great deal of time discussing the possibility of a fall middle school retreat at Bonclarken. While Bonclarken is willing to host a retreat, we realize that most of our churches are not meeting in person with their youth and are not comfortable with traveling with groups at this time. So, we began to think outside of the box about ways that we, as a PYC, could provide ministry opportunities to the youth of Foothills. PYC on the Road started to come to life. The youth began to get excited about the possibilities of sharing a theme with keynote, small group, energizers, and activities via Zoom or leading it in person! It could be done with individual churches or with one or more churches together.

PYC chose the theme "Behind the Mask" for this year! At our September meeting, we will begin working on a keynote, small group time, recreation, vespers, etc.! More information will be available to our churches very soon! Attached you will find scripture that the youth have chosen to help bring the theme to life. The youth began by discussing how difficult the beginning of quarantine was and how they felt they were missing out on so many things. The discussion led to great conversations about what we place importance on and the things that really matter in our lives. The youth all agreed that the longer Covid has continued, they have realized things that they thought were the most important in the beginning were not the things that matter the most.

The youth tossed around several ideas, we prayed and talked about each one. When someone mentioned "Unmasked" they all got excited. They agreed that there are so many masks that we all wear because society tells us we should be a certain way, friends tell us to act a certain way, schools tell us we must be a certain way to fit in, etc. and they even discussed how difficult it is to recognize people with masks on right now. Then we read the passages attached and focused on Romans 12 and realized that when the masks are removed and we are unmasked and are true selves that God created us to be that we are living into our calling. It was a gift to be able to watch the youth through this process.

Daniel Sansbury Bio & Call Statement May 16, 2020

I was fortunate, in the providence of God, to be raised by parents who took seriously their baptismal vows. My father, a life-long member of the Darlington, SC Presbyterian Church, served there as Sunday School teacher, deacon and elder. My mother, a native of Anderson, SC, was a typical mom of four Baby Boomer children. She served in the Presbyterian Women, Sunday School, Vacation Bible School, church retreats and much more. My father worked long-term as city attorney, plus his local law practice, and two terms in the state legislature. My mother, the former physical education teacher, taught Red Cross swimming lessons each summer for decades. Beyond our daily family devotions and every Sunday at church, we were taught that basic Presbyterian lesson: you are already loved and blessed by God, so share your blessings in service and witness to other people, in whatever opportunities come your way. I have always known "who made me," and why God made us all – "for his own glory."

For college, I attended USC in Columbia, as did my siblings, several cousins and future brothers-in-law. I knew throughout college that God had called me to the ordained ministry. I participated in the campus ministry led by the late Dr. Jerry Hammet, and worked three summers on staff at Camp Pee Dee, our presbytery camp. My next step was attendance at Columbia Theological Seminary, Decatur, GA. There I earned my Doctor in Ministry "in sequence" over the next 4 years.

During my seminary years, I sought to weave together my personal experiences of Christ at work in my life with the "faith seeking understanding" of Calvin and his successors. I was blessed to spend a summer, and then an entire school year, at the Pasadena Presbyterian Church, St. Petersburg, FL under the mentorship of Dr. Martin L. Harkey, Jr. "Marty" was a second career pastor. He had graduated from the University of Virginia with an electrical engineering degree, and worked for a time for General Electric. Then, in his 30's, his call to the ordained ministry led him to a long, successful and inspirational career in Anderson, SC and St. Petersburg. He was a remarkable role model for me! His faith interwove personal relationship to Jesus Christ, Savior and Lord and academic understanding and articulation of Christianity. He led the congregation well, while also being deeply involved with his people out of genuine affection for them. I have sought to have a similar pastoral career.

My first pastorate was a traditional church on the north side of Salisbury, NC. I then served almost six years in new church development on the west side of Fayetteville, NC near Fort Bragg. Although I had not served in the military, I felt called to begin this work that provided worship, fellowship and witness to young military families and retirees. That was followed by a 20-year role as senior pastor of the 550-member Rivermont Presbyterian Church in Chattanooga, and 7-plus years back in my home county as pastor of First Presbyterian Church, Hartsville, SC. Nearing retirement but looking for a different role in the Church, I served 13 months as interim pastor of First Presbyterian Church, Cheraw, SC. I will now be serving a second interim pastorate at Limestone Presbyterian Church, Gaffney. During that long tenure in Chattanooga, I went to Haiti three times. My life and ministry priorities were changed by the great needs as well as great opportunities for missionary service, there and in this state.

I have now served our Lord and his Church as an ordained pastor in four presbyteries in three states for 39 years. That includes 15 years on the Committee on Ministry. I was also a General Assembly commissioner in 1995, a member of the national Committee on Theological Education 1996-2003, the moderator of East Tennessee in 2007, and a synod commissioner in 2019.

I am married to Joye Chapman, a native of Cheraw. We have three young adult children and three grandsons. The adult years of my life have been filled with quite a variety of challenges and opportunities for faith and service. I give thanks again and again for God's gracious goodness to us all!

Daniel Sansbury May 16, 2020

Throughout my ministerial career, I have reads books by gifted preachers and writers like Tom Long, Barbara Brown Taylor, Fred Craddock, Frederick Buechner, and William Willimon. I just finished reading Willimon's <u>Accidental Preacher</u>, which is sort of an autobiography. He writes of his upbringing near Greenville, SC, and then service as Methodist pastor, chaplain at Duke University and later bishop. He looks at life and faith somewhat sideways, as I also do. The chapter titles of his book include "Fortuitous Baptism," "Inadvertent Summons," "Unplanned Disruptions" and "Serendipitous Writer."

This lengthy introduction to my own faith statement is my roundabout introduction to a life constantly surprised by the gracious love of God. As I have said or preached hundreds of times, we did not and could not earn this grace, nor could we deserve it (it is grace, after all). Further, we cannot lose it, for God is determined to love us in spite of ourselves. We live into the gracious promise of our Lord when he said, "You did not choose me but I chose you." [John 15.16] All we can do is receive, trust and share the good news about this amazingly gracious, persistent love of God in Jesus Christ. We live in gratitude for what God has already done for us through Jesus Christ!

I find great joy in gathering with God's people for worship! Our hymns, prayers, scripture readings and messages inspire us to explore and live into this grace. We are invited to imagine a kingdom of God on earth, and to take steps in faith toward that kingdom reality. A highlight of every worship service is the assurance of pardon and a congregational response like, "We Are Forgiven." We are not called and forgiven for our own ends, but for the world. I appreciate the "Six Great Ends of the Church" as clear statements of the overall purpose of God's Church. I seek to be an enthusiastic and faithful Presbyterian servant of our Lord.

Rev. Adam B. Fischer Biography and Call to Ministry

I was born and raised in Coeur d' Alene, Idaho, grew up in the Pacific Northwest, the middle of three sons, romping and roaming through the wild mountains, lakes, and forests. My favorite place to be was my grandparent's lake home where they maintained a more than 100-acre wildlife sanctuary on their property. I learned to admire God's creation and live as harmoniously with it as possible.

I have attended a Presbyterian Church since I was born and have always identified as a Christian. However, it wasn't until I was on a mission trip during my junior year at Albertson College that I began to feel a call to the ministry. In the streets of Tijuana, I awakened to the reality of inequality and injustice present in the world: it was clear that God's kingdom was not fully present and that there were many people seeking to build the Kingdom of God. Returning from that trip, I sought to embody Christ's call to serve the least and I began to see the face of Christ reflected in strangers, neighbors, friends, and foes. I was well supported and nurtured by a spiritual director, campus minister, and pastoral mentor who helped me recognize and understand my call to ministry.

I went to Louisville Presbyterian Theological Seminary feeling strongly called and completely out of my league because I graduated college with honors in psychology having only taken a single religion class. I quickly discovered seminary nurtured my gifts and honed my skills. I volunteered and lived in Cape Town, South Africa for four months where I learned about forgiveness, reconciliation, and resurrection through the people's stories and the wisdom of Linda Biehl and Archbishop Desmond Tutu. I was a Theological Advisory Delegate to 217th General Assembly in Birmingham. I was a candidate under care of the Presbytery of the Inland Northwest. After graduating with an M.Div., I continued my education and earned a Master of Theology with a focus on environmental ethics and eco-theology. Throughout all of these experiences, I learned to listen and speak to people with different Biblical interpretations, theological perspectives, cultural backgrounds and practices, and life journies. I continue to grow in understanding that the Body of Christ is one body with many members.

I have worked for the church in many ways. While earning my Th.M, I worked with the Presbyterian Hunger Program. I created the "Just Living" series to help people of faith embody the scriptures through practical living. I have written for Presbyterians Today, creating the 2012 Advent Calendar devotional, "Simple Gifts." I have worked with the Montreat Youth Conference leadership teams as s small group manual writer, small group trainer, and conference leader. I have served as a pastor in ordained ministry for more than a decade.

While living in Louisville and serving at Harvey Browne Memorial Presbyterian Church, I met the Rev. Mary Margaret Flannagan. We married in 2015 and dreamed of one day working together in ministry. We moved to Long Island, New York where we have been serving two churches in transition. During this time we have grown our family and welcomed two boys, Huck and Finch who remind us to see the world with wonder. I attended interim ministry training to bolster my skills as a transitional pastor. With the help of the Presbyterian Foundation, I shepherded First Presbyterian Church of Baldwin through Project Regeneration to nurture church growth and renewal. I helped the church discover their identity by having intentional conversations and developing a mission statement to articulate God's call. I chair the Salt and Light Committee, the Presbytery of Long Island's mission committee; we strive to empower and lead the presbytery to put their faith in action.

My life has been filled with many adventures and experiences. The Spirit has led me around the world to learn about the depth and breadth of God's mercy and love. I am excited to continue to grow as a pastor and partner with the church to share the Light of Christ with the world.

Faith Statement

I believe there is a cost to proclaiming Jesus Christ as Lord and Savior; it is to live sacrificially. I believe that people are saved by God's grace, and our response to the gift of grace is to do justice, love kindness, and walk humbly with God in defiance of evil, greed, and temptations of power. Foothills Presbytery Coordinating Council Report October 6, 2020

The Foothills Presbytery Coordinating Council had a Called Meeting (Zoom) on August 11, 2020 and reports the following:

- 1. Heard and unanimously approved recommendation of the Associate for Shared Mission and Ministry Search Committee and the Personnel Committee, to hire the Rev. Pressley Cox as the Associate for Shared Mission and Ministry with starting date of October 1, 2020.
- 2. Heard and approved the recommendation from the Personnel Committee, a monetary gift for the Rev. Gordon Raynal's years of service to Foothills Presbytery.
- 3. Heard and unanimously approved the recommendation from the appointed working group, to establish a **Foothills Presbytery Antiracism Ministry Team**, with the following scope, composition, and accountability:

Scope:

- a. Develop and recommend to Council:
 - Policy changes in the presbytery that will better reflect our commitment to antiracism
 - Opportunities for congregations and members of Foothills Presbytery to engage in conversation, education, and action that lead to the development of antiracist policies and practices in our congregations and the local communities to whom we bear witness.
- b. Collaborate with presbytery committees to pursue the goals of antiracism in the scope of their work.
- c. Explore our theology, anthropology, and sociology in light of the work of antiracism.

Composition: 9 members (3 classes of 3 members each, serving 3 years)
Co-chair, Person of Color, Co-chair, White, liaison to COM, liaison to CPM, liaison to CSM, liaison to the REC, 3 Members-at-large, and the Stated Clerk, Associate Stated Clerk, Associate for Shared Mission and Ministry, serving ex-officio. **Accountability:** Permanent Committee of Council

Members of the Task Force: Mike Hoyt, Chad Wright-Pittman, Lerone Wilder, Nath Briley, Michael Sullivan, Ex Offico: Debbie Foster, Pressley Cox, and Robin Morris

- 4. Heard and approved the following Presbytery Stated Meeting dates for 2021.
 - a. February 16, 2021
 - b. May 15, 2021
 - c. November 9, 2021

d. August 7, 2021 (if needed and virtual)

The Foothills Presbytery Coordinating Council met virtually for a Stated Meeting on October 6, 2020 and **reports** the following:

- 1. Heard a report from the Transition Think Tank updating Council on their continued efforts to think about the future shape of ministry. The TTT continues to partner with the Presbyterian Foundation on the Legacy Partnership Project. We were reminded that Foothills is a pilot presbytery for this work.
- 2. Council affirmed an email vote to enter into contract with Anderson Ridge Development LLC for the sale of the West Georgia Road property in the amount of \$1,050,000 with \$50,000 in earnest money. The contract is pending.
- 3. Heard and approved the recommendation that the Moderator elect be given a one-time exception from the policy in the Presbytery Manual of Operations, and be allowed to begin service one month early (February 2021).
- 4. Heard and approved the recommendation from the Finance and Stewardship Team, to establish the *Staying Connected Grants*. Offered in two rounds, these grants will provide funds for (1) technology and (2) local missional ministry. The grant (up to \$2,500 per church) will be given to five churches in each category. A church may only receive one grant per cycle.

The Coordinating Council recommends:

- 1. The election of the following slate for the Officers for Presbytery:
 - a. Associate Stated Clerk: January 1, 2021 December 31, 2023: Robin Morris
 - b. Treasurer: January 1, 2021 December 31, 2021: Stan Reid
 - c. Parliamentarian: January 1, 2021 December 31, 2021: De Calvert
 - d. Recording Clerk: January 1, 2021 December 31, 2021: Leland Burch
 - e. Assistant Recording Clerk: January 1, 2021 December 31, 2021: Phil Lyles
- 2. Update the Foothills Presbytery Manual of Operations to include the new the Antiracism Ministry Team. (first reading)
- 3. Extension of the Administrative Commission powers granted Council May 16, 2020 through the next in-person meeting of Presbytery. The Administrative Commission powers granted May 16, 2020 end on November 10. They are:
 - A. Upon recommendation of the Committee on Ministry, approve Honorable Retirements B. Upon the recommendation of the Examination Commission, approve the Ordination and Installation of Candidates for Ministry, and approve Ordination and/ or Installation Commissions
 - C. Upon the recommendation of the Committee on Preparation for Ministry, approve those under care to be approved as Candidates for the Ministry of Word and Sacrament.

4. At the 112th meeting of Foothills Presbytery (February 2020) the presbytery approved the Coordinating Council's recommendation to designate funds from the Presbytery's Investments. \$250,000 was approved for "the Scholarship Fund." Expecting an average annual return of 5%, the fund should yield approximately \$12,000 a year for scholarship assistance.

In March of 2020, we established a Scholarship Task Force to determine best practices in administering and managing the presbytery's new fund.

Over the course of several meetings, the group explored:

- Existing funds available through local churches to support of ministry students
- Tuition expense of training for service in the church (MDiv programs, CRE Lay School programs, and Certified Christian Education programs).
- Other expenses associated with training (housing, textbooks, travel, psychological testing and assessment).
- Amount anticipated annually from the presbytery's scholarship endowment.

On October 6th, Coordinating Council heard and approved the Scholarship Task Force's recommendation.

The Coordinating Council recommends:

Proceeds of the scholarship fund are allocated

- 1. 50% for grants to all those "under care" of Foothills Presbytery (those preparing for service as minister of Word and Sacrament, Commissioned Ruling Elder, or Certified Christian Educator). These grants are capped annually at \$500 for M.Div. students and \$300 for CRE and CCE students. Grant funds be allocated 75% to M.Div. students and 25% to CRE and CCE students, divided equally among all students under care during the year. Any grants not accepted will be added to the financial needs-based allocations.
- 2. The remaining funds are allocated for need-based financial aid.

The current Scholarship Task Force will remain in place and oversee the 2021 distribution of funds and make recommendations on any policy revisions for the future.
